NOTICE OF NON-DISCRIMINATION
&
SEXUAL HARASSMENT POLICIES & GRIEVANCE PROCEDURES

I. Policy

It is the policy of Butte Academy of Beauty Culture to maintain an environment for students, faculty, administrators, staff, and visitors that is free of all forms of discrimination and harassment, including sexual harassment. The Butte Academy of Beauty Culture has enacted the Sexual Harassment Policies & Grievance Procedures (the "Policy") to reflect and maintain its institutional values, to provide for fair and equitable procedures for determining when this Policy has been violated, and to provide recourse for individuals and the community in response to violations of this Policy.

The Butte Academy of Beauty Culture does not discriminate on the basis of sex in its educational, extracurricular, or other programs or in the context of employment. Sex discrimination is prohibited by Title IX of the Education Amendments of 1972, a federal law that provides:

No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance.

This Policy prohibits all forms of sex discrimination, harassment, and misconduct, including sexual assault, domestic violence, dating violence, and stalking. The requirement not to discriminate in the Butte Academy of Beauty Culture's education programs or activities extends to admission. This Policy also prohibits retaliation against a person who has made a report or complaint, testified, assisted, or participated or refused to participate in any manner in an investigation, proceeding, or hearing under this Policy. Inquiries about the application of Title IX may be referred to the Butte Academy of Beauty Culture's Title IX coordinator, the U.S. Department of Education Office for Civil Rights, or both.

The Butte Academy of Beauty Culture also prohibits other forms of discrimination and harassment, including discrimination and harassment on the basis of race, color, national origin, disability, or age in its programs and activities. Butte Academy of Beauty Culture desires to create and sustain an anti-discriminatory environment and will not tolerate discrimination of any kind. The Butte Academy of Beauty Culture will achieve this through education, orientation, and training for all

students, staff, and faculty for the purpose of creating awareness of both the issues surrounding discrimination as well as accountability, sensitivity training, and anti-discrimination training in their classrooms, at least once while the student is in the Butte Academy of Beauty Culture.

II. Sexual Harassment Grievance Procedure

Reports of sexual harassment should be made to the Butte Academy of Beauty Culture's Title IX Coordinator or to a Designated school Official. As set forth in the Policy, the Butte Academy of Beauty Culture's Designated School Officials are the Schools Owner, and Title IX Coordinator. The Butte Academy of Beauty Culture will respond promptly when it has actual knowledge of sexual harassment in its education programs or activities. The Title IX Coordinator will promptly contact the complainant to discuss the availability of supportive measures, consider the complainant's wishes with respect to supportive measures, inform the complainant of the availability of supportive measures with or without the filing of a formal complaint, and explain to the complainant the process for filing a formal complaint.

The Butte Academy of Beauty Culture will investigate all formal complaints of sexual harassment. A formal complaint must be in writing, filed by a complainant or signed by the Title IX Coordinator alleging sexual harassment against a respondent, and request that the Butte Academy of Beauty Culture investigate the allegation of sexual harassment. A formal complaint form may be obtained from the Title IX Coordinator, although no particular form is required to submit a formal complaint so long as the complaint is in writing, signed by a complainant, alleges sexual harassment against a respondent, and requests an investigation. The Butte Academy of Beauty Culture's Title IX Coordinator oversees the Butte Academy of Beauty Culture's investigation, response to, and resolution of all reports of prohibited sexual harassment, and of related retaliation, involving students, faculty, and staff.

If all parties voluntarily agree to participate in an informal resolution that does not involve a full investigation and adjudication after receiving notice of a formal complaint and if the Butte Academy of Beauty Culture determines that the particular formal complaint is appropriate for such a process, the Butte Academy of Beauty Culture will facilitate an informal resolution to assist the parties in reaching a voluntary resolution. The Butte Academy of Beauty Culture retains the discretion to determine which cases are appropriate for voluntary resolution.

The Butte Academy of Beauty Culture will convene a hearing panel following the end of an investigation. The hearing panel determines whether the respondent is responsible or not responsible for a violation of the Policy. If the respondent is determined to be responsible, the hearing panel's written determination will include any disciplinary sanctions the Butte Academy of Beauty Culture imposes on the respondent. The Policy provides that the parties have the right to appeal the hearing panel's determination under certain circumstances.
